**3. PROFILE OF SKILLS AND COMPETENCES**

- Create, communicate and present technical event concepts supporting implementation of the event objective while taking into account artistic, design, technical, commercial and legal requirements
- Responsibly plan the implementation of a technical event concept from a technical, organisational, commercial and legal perspective
- Lead the implementation of technical planning in all phases of the event while taking into account changing circumstances
- Conclude technical event projects by revisiting, evaluating and documenting technical, organisational and commercial processes.
- Direct, monitor and optimise company processes; analyse company requirements and risks; budget for revenue, expenditure and investments and also support business decision-making processes; organise health and safety in the company.
- Direct employees and allocate tasks; instruct employees on how to act in an independent and responsible manner, prepare and organise initial, advanced and continuing education and training
- Organise inspection and maintenance facilities and work equipment to ensure safety and operational readiness, monitor the availability of work equipment and materials as well as its procurement, transport, storage and disposal
- Monitor and assess the development of event markets

**4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE**

Certified senior event technology specialists work in companies of different types and scope, in particular for broadcasting and television companies, for event technology service providers, at conferences and trade fairs and in opera houses, theatres and concert halls.  
They design, plan, direct and evaluate the technical implementation of various types of events, assist in their operational organisation and take on leadership roles.

6. OFFICIALLY RECOGNIZED WAYS OF ACQUIRING THE CERTIFICATE	
<p>The certification of the advanced vocational education and training is obtained by passing an examination before a competent body specified under 5. Before admission to the examination, candidates must provide proof of</p> <ol style="list-style-type: none"> <li>1. successful completion of a final examination in the recognised training occupation of event technology specialist and then at least one year of relevant professional practical experience or</li> <li>2. successful completion of the final examination in another recognised training occupation followed by at least two years of relevant occupational experience or;</li> <li>3. at least five years of relevant occupational experience or;</li> <li>4. relevant vocational skills and competencies;</li> <li>5. attainment of certificates of qualification in VET: vocational and professional education studies.</li> </ol>	

#### **Additional information**

The skills and competences of which proof is to be furnished in the further training examination are usually acquired during many years of practical work and within the framework of education measures. Courses are offered in preparation for the examination; their duration and content is geared to the different specialist and managerial tasks.

Passing the examination also confers the qualifications required to provide training on the certificate holder, pursuant to Section 30 Para 5 Vocational Training Act (*Berufsbildungsgesetz*).

Translations of the certificate can be obtained from the competent body named in section 5 above.
