3. PROFILE OF SKILLS AND COMPETENCES

- · Work either alone or with others to execute works on the basis of technical documentation and work orders
- · Plan, prepare and organise work tasks and coordinate work with persons involved in the construction works
- Set up, secure, maintain and clear construction sites and initiate measures to safeguard the work process and ensure safety, health and safety at work and environmental protection at the construction site
- Implement quality assurance measures and document own work results
- · Prepare measurements
- · Carry out measurements, use and apply plans and drawings, prepare sketches, including digitally
- · Operate and maintain tools, machinery and plants
- Erect and dismantle working and protective scaffolding in accordance with stipulations
- · Operate and maintain construction machinery, equipment and vehicles
- Produce construction components in concrete and reinforced concrete
- Produce structures made of blocks
- Carry out demolition and dismantling works using construction machinery and equipment whilst deploying protective and safety measures
- Carry out drilling and separation procedures using machines and tools and conduct thermal separation procedures whilst deploying protective and safety measures
- Separate and store demolition waste and arrange for disposal
- Carry out related works in the construction, finishing and civil engineering sectors.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Building mechanics for demolition and concrete cutting are principally employed in the main construction industry. They may work for demolition firms or for companies which specialise in the stripping of buildings and/or in concrete drilling and cutting.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body:

- 1. after completion of dual training in a company and at part-time vocational school (normal procedure)
- 2. after retraining in a recognized training occupation
- 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions

Additional information

Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.

Duration of training: 3 years.

Training in the "dual system":

The knowledge, skills and competences delivered in a training occupation are based on the typical requirements of work processes and prepare the trainees for a specific job as well as for further qualifications. **The training is provided in a company and at vocational school:** Trainees spend 75% of the duration of training in the company. Here they acquire practical skills in a real working environment. Trainees complete 25% of training time in vocational school where they are taught general and vocational knowledge as it relates to their training occupation.
