3. PROFILE OF SKILLS AND COMPETENCES

- Work either alone or with others to execute works on the basis of technical documentation and work orders
- Plan, prepare and organise work tasks and coordinate work with persons involved in the construction works
- Set up, secure, maintain and clear construction sites and initiate measures to safeguard the work process and ensure safety, health and safety at work and environmental protection at the construction site
- Implement quality assurance measures and document own work results
- Prepare measurements
- Invoice for services provided and draw up site plans
- Operate and maintain tools, machinery and plants
- Erect and dismantle working and protective scaffolding in accordance with stipulations
- Carry out measurements, use and apply plans and drawings, prepare sketches, including digitally
- Build frame, large-panel and special formworks for foundations, right-angle supports and beams, multiform elements and walls and ceilings
- Erect, brace and anchor sub-assemblies, produce formworks for visible concrete, conical forms, support pillars, landings and straight and spiral stair flights including system formworks
- Build and install reinforcing members and prepare reinforcement elements
- Install pre-stressed steel with anchor systems
- Test fresh and hardened concrete
- Deliver, feed and compress concrete and treat concrete and the surface manually and mechanically
- Process concrete surfaces in accordance with design criteria
- Underpin parts of buildings
- Seal concrete and reinforced concrete constructions against pressing water
- Build interior and exterior walls using various types of block and a range of bonding techniques
- Produce structures made of blocks
- Carry out energy efficiency noise protection and fire protection measures in and on components and construction sub-assemblies
- Check concrete surfaces for damage and carry out maintenance and refurbishment work on concrete and reinforced concrete structures
- Carry out related works in the construction and civil engineering sectors.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Concretors work for construction companies and in prefabricated construction in such areas as housing developments, office developments, public-sector construction projects, commercial and industrial building sites and infrastructure. They may also be employed in the manufacture of concrete and of prefabricated components.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> 1. after completion of dual training in a company and at part-time vocational school (normal procedure) 2. after retraining in a recognized training occupation 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions
<p>Additional information</p> <p>Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p>Duration of training: 3 years.</p> <p>Training in the "dual system": The knowledge, skills and competences delivered in a training occupation are based on the typical requirements of work processes and prepare the trainees for a specific job as well as for further qualifications. The training is provided in a company and at vocational school: Trainees spend 75% of the duration of training in the company. Here they acquire practical skills in a real working environment.
