- Set up and fit wire drawing, separation or metal forming machines
- Securely transport wire coils and rings and metal forming parts
- Evaluate surface and heat treatment conditions of wires and metal forming parts
- Carry out adjustment, maintenance and servicing works on installations, machines and tools
- Maintain operating equipment
- Determine the mechanical parameters of wires and metal forming parts
- Evaluate metal forming tools and carry out measurement corrections
- Monitor and improve production processes
- Carry out quality assurance measures
- Cooperate with upstream and downstream divisions.

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> 1. after completion of dual training in a company and at part-time vocational school (normal procedure) 2. after retraining in a recognized training occupation 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions
<p>Additional information</p> <p>Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p>Duration of training: 2 years.</p> <p>Training in the "dual system": Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. The training is provided in a company and at part-time vocational school: In the company, the trainees acquire practical skills in a real working environment.
