#### 3. PROFILE OF SKILLS AND COMPETENCES

- · Carry out work in an autonomous and customer oriented manner on the basis of work orders working both alone and as part of a team
- · Plan and coordinate work, stipulate stages of work and materials required
- · Initiate safety, health and safety at work and environmental protection measures in the workplace
- · Conduct discussions with customers
- Check the quality of the work for any errors in execution, document works
- · Carry out quality assurance measures and record quantities and time spent for calculation of the services provided
- Check and evaluate underlying surfaces and prepare such surfaces for final coating
- Carry out protective measures for surfaces not to be treated
- · Coat, treat and design surfaces
- · Produce lettering, designs and ornamental lacquering
- Maintain and repair surfaces
- · Check the correct functioning of electrical, electronic, pneumatic and hydraulic components and systems
- Carry out disassembly and assembly work and glazing on vehicles
- · Carry out repair work on vehicles and parts of vehicles
- Conduct measurements and document results
- · Select, set up, operate and maintain implements, tools, machines and equipment for the job at hand
- · Process materials and components.

### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Vehicle varnishers work at vehicle varnishing shops in the craft trades sector. They also find employment at bodywork repair workshops and in the vehicle industry.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body:

- 1. after completion of dual training in a company and at part-time vocational school (normal procedure)
- 2. after retraining in a recognized training occupation
- 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions

#### **Additional information**

**Entry requirements:** Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.

**Duration of training:** 3 years.

#### Training in the "dual system":

Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. **The training is provided in a company and at part-time vocational school**: In the company, the trainees acquire practical skills in a real working environment. On one or two days per week, the trainees attend part-time vocational school, where they are taught general and vocational knowledge related to their training occupation.
