3. PROFILE OF SKILLS AND COMPETENCES

- Use a range of grinding and polishing techniques on surfaces and edges to process sheet glass in particular
- Modify the edges and surfaces of workpieces
- Produce sandblasted matt and etched surfaces in different depths, colour tones and structures
- Apply surface coatings, particularly in silver
- Melt and shape glass and materials which are similar to glass
- Join workpieces to create flat and three-dimensional glass designs and constructions
- Install and remove glass designs and glass products
- Carry out repairs to glass designs and glass products
- Use sawing, drilling, grinding and polishing techniques to process and make glass products and materials which are similar to glass
- Apply surface finishes to glass and glass products using chemical and mechanical techniques
- Prepare drawings and draft designs
- Design ornaments, decorative finishes, lettering and monograms
- Produce complex glass designs
- Measure dimensions and draw up documents
- Handle tools, instruments and machines
- Plan and coordinate work both alone and as part of a team and work in a customer oriented manner on the basis of technical documentation, designs and work orders
- Use information and communication systems and carry out measures for health and safety at work and for environmental protection
- Check, evaluate and document work and carry out quality assurance measures.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Glass finishers specialising in edge and surface finishing mainly work at craft trades and industrial companies in the glass finishing sector or in the glass finishing departments at glass works. They may also find employment in glazier's workshops.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> <li>1. after completion of dual training in a company and at part-time vocational school (normal procedure)</li> <li>2. after retraining in a recognized training occupation</li> <li>3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions</li> </ol>
<p><b>Additional information</b></p> <p><b>Entry requirements:</b> Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p><b>Duration of training:</b> 3 years.</p> <p><b>Training in the "dual system":</b> Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. <b>The training is provided in a company and at part-time vocational school:</b> In the company, the trainees acquire practical skills in a real working environment.
