## 3. PROFILE OF SKILLS AND COMPETENCES

- Cross-cutting skills, knowledge and competencies making up the occupational profile
- Work either alone or with others to execute works on the basis of technical documentation and work orders
- Plan, prepare and organise work tasks and coordinate work with persons involved in the construction works
- Set up, secure, maintain and clear construction sites
- Initiate measures to safeguard the work process and ensure safety, health and safety at work and environmental protection at the construction site
- Implement quality assurance measures and document own work results
- Prepare measurements
- Operate and maintain tools, machinery and plants
- Erect and dismantle working and protective scaffolding in accordance with stipulations
- Carry out measurements, use and apply plans and drawings, prepare sketches, including digitally
- Carry out energy efficiency noise protection and fire protection measures in and on components and construction sub-assemblies
- Modify and dismantle construction components
- Carry out related works in the construction and civil engineering sectors, Further skills, knowledge and competencies in the following specialisms, In the specialism of masonry work:
  - Produce structures made of blocks, in particular build single-leaf and multiple-leaf walls, facings, steps, surrounds, infillings and shafts
  - Produce construction components in concrete and reinforced concrete, in particular erect formworks, install reinforcing members. and feed and check concrete, In the specialism of concrete and reinforced concrete work:
  - Produce construction components in concrete and reinforced concrete, in particular erect formworks including for conical forms and system formworks, install reinforcing members, feed and check concrete and manually process concrete surfaces
  - Produce structures made of blocks, in particular create exterior and interior walls, In the specialism of furnace and chimney construction:
    - Produce structures made of blocks, in particular build fireproof constructions and chimney duct pipes and set and mount installation and add-on parts in chimney duct pipes
    - Produce construction components in concrete and reinforced concrete, in particular erect formworks including for conical forms, install reinforcing members, feed and check concrete and manually process concrete surfaces, In the specialism of demolition and concrete cutting:
  - Modify and dismantle construction components, in particular carry out drilling and separation procedures and demolition procedures using tools, machines and accessory equipment
- Separate, sort and store demolition waste and organise recycling and disposal.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Building construction workers principally find employment with companies involved in the main construction industry. Depending on their training specialism, they work in various areas within the construction industry.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> <li>1. after completion of dual training in a company and at part-time vocational school (normal procedure)</li> <li>2. after retraining in a recognized training occupation</li> <li>3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions</li> </ol>
<p><b>Additional information</b></p> <p><b>Entry requirements:</b> Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p><b>Duration of training:</b> 2 years.</p> <p><b>Training in the "dual system":</b> The knowledge, skills and competences delivered in a training occupation are based on the typical requirements of work processes and prepare the trainees for a specific job as well as for further qualifications. <b>The training is provided in a company and at vocational school:</b> Trainees spend 75% of the duration of training in the company. Here they acquire practical skills in a real working environment.
