3. PROFILE OF SKILLS AND COMPETENCES

- · Check the functionality, operational safety and fire safety of technical plants and installations in furnace rooms and in plants and rooms used for the storing and supply of fuel
- Develop proposals for the rectification of risks and operational malfunctions
- · Check technical plants and installations with a view to energy saving and environmental protection, evaluate, assess and document results
- Identify, evaluate and document operational malfunctions and act autonomously in initiating immediate measures to avoid risk to man and the environment
- Sweep, clean and check furnace plants, ventilation plant and similar installations according due consideration to safety and protection regulations
- Document the actual and target status of technical plants and installations
- Advise customers on technical matters relating to furnaces, environmental protection and climate protection observing neutrality with regard to competitors
- · Handle tools, measuring equipment and testing devices
- The areas of activity of a chimney sweep are laid down in federal legislation (Chimney Sweep Act).
- Chimney sweeps carry out their duties in the public interest.
- · They apply construction law, fire protection regulations, environmental and climate protection regulations and regulations on the rational use of energy.
- Execute work activities in an autonomous manner according due consideration to quality assurance, safety, and health and safety in the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Chimney sweeps find employment opportunities at craft trades companies. They work for small companies run by an authorised master craftsman in chimney sweeping for a particular district or else are employed at recognised chimney sweeping companies.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body:

- 1. after completion of dual training in a company and at part-time vocational school (normal procedure)
- 2. after retraining in a recognized training occupation
- 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions

Additional information

Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.

Duration of training: 3 years.

Training in the "dual system":

Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. **The training is provided in a company and at part-time vocational school**: In the company, the trainees acquire practical skills in a real working environment. On one or two days per week, the trainees attend part-time vocational school, where they are taught general and vocational knowledge related to their training occupation.
